#### **GENERAL INSTRUCTIONS**

Sabakem Epoxiconazole 125 SC Fungicide is a broad-spectrum contact and systemic fungicide. It is taken up via the stem and foliage and is translocated upwards and outwards to provide protection to new growth. Thorough coverage of the crop is necessary for best
